A good response could be, "A job where my work ethic and abilities are recognized and I can make a meaningful difference to the organization."

Question # 25

If you have seven white socks and nine black socks in a drawer, how many socks do you have to pull out blindly in order to ensure that you have a matching pair?

Answer:-

if the first one is one color (say, white), and the second one is the other color (black), then the third one, no matter what the color, will make a matching pair. (Sometimes you're not supposed to think that hard.)

This was to ensure there wasn't any "wrongdoing" at the company by any of the cashiers and I was always accurate in my reports.

Multi-tasking is an important part of most jobs. You want to show that you're good at it but not overwhelmed with it. OR Sir, I would like to have my feedback, so that I can analyze and improve my strengths and rectify my shortcomings.

What's a time you exercised leadership?

Answer:-

Depending on what's more important for the the role, you'll want to choose an example that showcases your project management skills (spearheading a project from end to end, juggling multiple moving parts) or one that shows your ability to confidently and effectively rally a team. And remember: "The best stories include enough detail to be believable and memorable,".
