Keep it simple: "Unfortunately, I was let go," is a totally OK answer.

Keep answers short and to the point, avoiding diatribes causing candidates to appear insincere.

Think of lessons learned in extra curricular activities, in classes that had a profound impact on your personal development. # Answer-

Think about a time where you've rallied a group of people around a cause / idea / initiative and successfully implemented it. It could be a small or large project but the key is you want to demonstrate how you were able to lead others to work for a common cause.

Do you have the ability to articulate a vision and to get others involved to carry it out?

# Answer:

If yes, then share an example of how you've done so at work or college. If not, then discuss how you would do so. Example: "I would first understand the goals of the staff members and then I would align those to the goals of the project / company. Then I would articulate the vision of that alignment and ask them to participate. From there, we would delegate tasks among the team and then follow up on a date and time to ensure follow through on the tasks. Lastly, we would review the results together."

### Answer:

Examine the trends of the company and also where there may be some weaknesses (news articles often document this on public companies or look at their competitors to see how they're positioning it against them.) Make sure you do your research on their competitors. You can find this by going to yahoo finance and click on their competitors (if they are public). You can also research local regional companies that are their competition (if it's a smaller private company on a regional scale) by simply typing in similar product offerings in the Google search followed by the city. Make sure you know their competitor's vision, products, culture, and how they are differentiated against their competition (and if they're not, how they could be)
