Question #1

The first thing you should do is discuss experience you have the interviewer is unfamiliar with. However, only state this if you can live up to these expectations.

Question # 23

What differentiates this company from other competitors?

Answer-

Be positive and nice about their competitors but also discuss how they are better than them and why they are the best choice for the customer. For example: "Company XYZ has a good product, but I truly believe your company has a 3-5 year vision for your customer that aligns to their business needs."

Answer:-

Do your research before answering this question - first, consider what the market average is for this job. You can find that by searching on Google (title followed by salary) and globalguideline.com and other websites. Also - make sure if you aim high you can back it up with facts and your previous results so that you can make a strong case.

Make sure you know their competitor's vision, products, culture, and how they are differentiated against their competition (and if they're not, how they could be)

However, saying that you are willing and then complaining about the hours once you start working is a recipe for disaster.
